Top Reasons Why the Hayes Township Board Needs to Be Replaced

- Failed to file required annual financial reports to State of Michigan on time, 5 years in a row. Failed to file required bi-annual audits on time in 2020 & 2022.
- Audits for 2022 and 2023 exposed Board's inability to do accurate accounting and budgeting, and several violations of state law, requiring yearly audits and more costs.
- Board never amends the budget, violating state law.
 Auditor said: "The Township Board of Trustees was not aware of the true financial status of any of the Township's funds and; therefore could not make any sound financial decisions."
- Clerk's inability and unwillingness to produce reports on the status of the budget or on total expenses paid.
- EMS services now cost Hayes taxpayers \$397,000* per year in a separate EMS millage. Previous costs, about \$38,000 per year. *See Charlevoix County Equalization Apportionment report for 2023.
- Unreported \$98,027 unpaid bill owed to City of Charlevoix for past EMS services.
- This Board put the Township in long-term debt for over \$1 million for EMS station. If EMS millage ever fails, the Township is on hook for entire debt.
- No transparency. Board regularly votes with no discussion. Important records are not on website, requiring residents to request them through FOIA (Freedom of Information Act).
